**NOTICE OF ELECTION**

Notice is hereby given that Landowners and Board of Supervisors (the "Board") of the Central County Water Control District ("CCWCD") will hold their Annual Landowners' Meeting, Organizational and Regular Meeting, and conduct an election for a Supervisor to Seat #1 & Seat #5 of the Board on Saturday, October 22, 2022, at 255 North Hacienda Street, in Clewiston, Florida.

**ANNUAL LANDOWNERS' MEETING & ELECTION**

The Annual Landowners' Meeting will commence, and polls will open for voting at 9:00 a.m. on October 22, 2022, at the Montura Ranch Estates Clubhouse at 255 North Hacienda Street in Clewiston, Florida. Polls will close at 3:00 p.m. on October 22, 2022. After the polls close, votes will be tabulated and results announced. The purpose of the Annual Landowners' Meeting is to elect a Supervisor, who will serve 4-year terms, for Seat #1 Seat #5 of the Board; to receive the annual report of the District Engineer and audit of the District's books; to consider the Supervisors' compensation; and to transact any other business as may be appropriate.

In order to vote, Landowners must present a picture I.D. to confirm his or her identification as a voter in the District election. If you have paid your assessments to the District within 30-days of October 22, 2022, please be prepared to present a receipt or proof of payment of your assessments to the District prior to casting your vote. If you acquired title to real property in the District within 30-days of October 22, 2022 and/or your name is not reflected on the Hendry County tax roll, please be prepared to provide proof of land ownership prior to casting your vote.

**ORGANIZATIONAL & REGULAR (OCTOBER) MEETING OF THE BOARD**

The Organizational and Regular (October) Meeting of the Board will occur at 3:30 p.m., or immediately following the Annual Landowners' Meeting on October 22, 2022, at the Montura Ranch Estates Clubhouse at 255 North Hacienda Street in Clewiston, Florida. The Board's Regular Monthly Meeting will be simultaneous with the Organizational Meeting. The purpose of the Organizational Meeting and Regular (October) Meeting will be to choose a President and Secretary of the Board and conduct the District's regular business.

If any person decides to appeal any decision made by the Board at any of the above referenced-meetings, that person will need a record of the meetings and, for such purpose, that person will need to ensure a verbatim record of the proceeding is made, which includes the testimony and evidence upon which any appeal is based.
