

RESOLUTION 22- 4

A RESOLUTION OF THE BOARD OF SUPERVISORS OF CENTRAL COUNTY WATER CONTROL DISTRICT ADOPTING A BUDGET FOR THE FISCAL YEAR ENDING ON SEPTEMBER 30, 2023; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the Central County Water Control District (the "District") is a Florida water control district operating and organized under Chapter 298, Florida Statutes, and Chapter 70-702, Laws of Florida, as amended; and

WHEREAS, on August 24, 2022, the District Board of Supervisors (the "Board") adopted a final budget for the Fiscal Year ending on September 30, 2023; and

WHEREAS, on August 24, 2022, the Board considered the Final Budget for the Fiscal Year ending on September 30, 2023.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of the Central County Water Control District as follows:

Section 1. The budget for the fiscal year ending on September 30, 2023, which is attached and incorporated herein as **Exhibit A**, is hereby ADOPTED in accordance with section 189.016(3), Florida Statutes.

Section 2. This Resolution shall become effective immediately upon its adoption.

Section 3. The District Manager or his designee is directed to immediately publish District's Final Budget to the District Website.

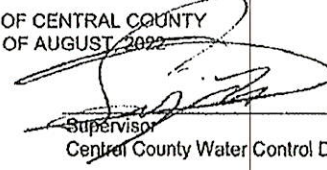
